BEGIN TUESDAY, SEPTEMBER 6, 2011**

**(Keene Elementary Schools: Kindergarten begins MONDAY, September 12)**

**1. Opportunity to Register**

- a. All pupils not previously registered should be registered by the day before school begins. Pupils in attendance at the close of the 2010-2011 school year are not required to register again.
- b. Children registered for Kindergarten in April 2011, are not required to register again.  
**Keene: Kindergarten Screenings Tuesday, September 6 and Wednesday, September 7**  
(Contact your school for appointment)
- c. All changes in address during the summer months must be reported to the principal in the school area in which now residing and/or registered.
- d. School personnel will be available most days at all **KEENE, CHESTERFIELD, MARLBOROUGH** and **WESTMORELAND** schools to register new pupils. (A telephone call to the school prior to going is recommended to ensure someone is available or to make an appointment for registering your children).
- e. Students in **HARRISVILLE** may register **Friday, August 19, 2011, from 9:00 a.m. to 3:00 p.m.**

Students in **MARLOW** may register **Wednesday, August 24, 2011, from 9:00 a.m. to 12:00 p.m.** and **Wednesday, August 31, 2011, from 9:00 a.m. to 12:00 p.m.**

Students in **NELSON** may register **Wednesday & Thursday, August 17 & 18, 2011, from 9:00 to 11:00 a.m.**

**2. Special Requirements**

- a. Birth certificates must be submitted for new pupils in Kindergarten and Grade 1. Proof of residency (i.e., current utility bill, lease, pay stub, etc.) must be submitted for *all* new students.
- b. Entrance age -- Children residing in **Chesterfield, Harrisville, Keene, Marlborough, Marlow, Nelson and Westmoreland**: Kindergarten, at least five by September 30, 2011; Grade 1, at least 6 by September 30, 2011. **In Keene, proof of residency of the student and/or his/her legal guardian(s) will be required by the school Principal at the time of registration and annually thereafter.**
- c. New Hampshire R.S.A. 200:32 requires "**There shall be a complete medical examination by a licensed physician of each child prior to or upon first entry into the public school system.**"
- d. New Hampshire R.S.A. 200:38 requires "**All children shall be immunized prior to school entrance according to the current recommendations of the state public health agency.**"
